Authorization for release of juvenile records.

You are requesting Mauston Police Department records that contain juvenile information. Wisconsin State Statutes (2019-2020) prohibit the release of juvenile records except in specific instances. The Mauston Police Department may (subject to state law and department policy) release juvenile records to those requestors whose relationship to the juvenile is (check one):

- Parent whose parental rights have not been terminated *.
- Guardian named by the Court (provide documentation showing Court appointment) *.
- Person assigned by court to be juvenile's legal custodian (provide documentation) *.
- Juvenile who is 14 years of age or older and is requesting their own report *.
- A school district administrator, administrator of a private school, or administrator of a tribal school, or designee of a school district administrator, private school administrator, or tribal school administrator, subject to Wis. Stat. §938.396(1)(c)(3).
- A victim of a juvenile's act seeking any information relating to the injury, loss or damage suffered by the victim, including the name and address of the juvenile and the juvenile's parents. The victim may use and further disclose the information only for the purpose of recovering for the injury, damage or loss suffered as a result of the juvenile's act, Wis. Stat. §938.396(1)(c)(5).
- The insurer of the victim, as defined in Wis. Stat. §938.02(20m)(a)1., may request a law enforcement agency to disclose to the insurer any information in its records relating to the injury, loss or damage suffered by the victim, including the name and address of the juvenile and the juvenile's parents. The insurer may use and further disclose the information only for the purpose of investigating a claim arising out of the juvenile's act when that juvenile has been ordered to make restitution for injury, loss or damage caused by the juvenile and if the juvenile has failed to make that restitution within one year after the entry of the order.

***A photo ID and the juvenile's birth certificate are required to obtain the records. Enclose photocopies of each when you mail in your request or present them in person at the Mauston Police Department.**
